2023 - 2024 BUDGET NEWSLETTER

Dear District Residents:

As **Proposition I,** The Board of Education submits the 2023-2024 District Expenditures for community approval. The \$20,727,836 proposed expenditure represents an increase of \$1,348,825 or 6.96% more than last year's budget.

Our most significant increases reflected in this year's budget are in the areas of program and non-instructional contractual obligations as well as inflationary impacts on supplies, equipment and service. Contracts with both the SRP and MWTA bargaining units were ratified last year with health insurance changes that have resulted in a relatively low increase in premium costs this year. We appreciate the willingness of both units to work collaboratively with the district to ensure solid financial ground for our current and future students. We continue to see a significant increase in our occupational education program costs as student enrollment in BOCES programs remains high. The opportunities available for our students through these programs makes this a definite worthwhile expenditure.

We are also gearing up for a capital project that will likely be somewhere in the \$14M range, and we are hoping to present this to district voters in the fall for approval with a zero net increase to the tax levy. We are earmarking \$200,000 in this year's budget to be leveraged along with capital reserves to offset the gap that State Building Aid does not cover for the project thus allowing the project to be financed without requesting an increase in the tax levy.

This year represents the final year of phase-in for full foundation aid so this will be our last large increase in aid for the foreseeable future. We are taking a conservative approach with the 23-24 budget as aid increases for the following year will likely be quite uncertain. Our aid increase combined with an \$800,000 fund balance allocation allows the District to stay under the allowable tax cap of 2.93% with a recommended tax levy increase of \$63,507 or 1.343%.

We are continuing to utilize the American Rescue Plan Act funds according to our plan, and remain highly focused on providing additional opportunities for our students through after school programs and summer enrichment opportunities.

Proposition II is the election of two members to the nine (9) member Board of Education. There are two candidates that have filed petitions and we are very appreciative that both incumbents have decided to run again. Thank you to Charles Grant and Katie Logan as they seek voter approval to continue to serve their community.

Proposition III requests community approval for the purchase of two 72-passenger buses, one 7-passenger van, and one stake-rack plow truck. Inflation is absolutely having an effect on the prices for these purchases, however we have a healthy transportation reserve and our transportation expenses are 90% reimbursable by the State so this proposition will have no effect on the tax levy.

Proposition IV seeks community approval to continue the process of engaging in an annual capital outlay project. Districts in New York State are allowed to conduct yearly capital outlay projects that cost no more than \$100,000 with voter approval. Capital outlay projects are reimbursed at our building aid ratio which is currently 90% so the net cost to the district is approximately \$10,000. This year's project will continue our window replacement schedule in the elementary wing. The reimbursement from last year's project provides 90% of the funding for the new project and the remaining funds will be taken from our building reserve so as to not affect the tax levy.

Propositions to be voted on May 16, 2023

PROPOSITION I: BUDGET

Shall the Board of Education of the Madrid-Waddington Central School be authorized to expend the sum of \$20,727,836 for the 2023 -2024 school year and to levy the necessary tax for this purpose.

PROPOSITION II: BOARD OF EDUCATION

- The election of two (2) members to the nine (9) member Board of Education.
- Two (2) five-year terms are open.
- Candidates include the following:

The ballot will be accepting write-in candidates.

PROPOSITION III: BUS PURCHASE

Resolved that the Board of Education of the Madrid-Waddington Central School District be authorized and directed to purchase two (2) 72-passenger buses, one (1) 7-passenger van, and one (1) stake-rack truck to expend therefore an aggregate sum, not to exceed \$525,000; which sum shall be raised by tax on the taxable property of the District; and That the Board of Education be authorized to expend funds from the existing Transportation and Equipment Capital Reserve Fund to fund the cost of the buses and vehicles in whole or part: and

That the Board of Education be authorized in accordance with the provisions of the Education and Local Finance Law to borrow on the credit of the District a sum, not to exceed \$525,000, to fund the cost of the buses and vehicles to issue obligations of the District not to exceed that amount to finance the purchase of the buses and vehicles in whole or part.

PROPOSITION IV: CAPITAL OUTLAY

Resolved that the Board of Education of the Madrid-Waddington Central School District be authorized and directed to expend up to \$100,000 from the Building Reserve in part or whole which includes the removal of windows in select classrooms and offices and installation of new thermally broken, aluminum double hung windows with insulated glass. The size and color of the new windows will match the existing windows. Work will also include painting the existing steel lintels above the windows and sealing the perimeter of the window units.

The proposed educational spending plan for the upcoming school year at Madrid-Waddington represents a spending increase of 6.96%, or \$1.348.825 Our operation will require a tax rate of 1.343%, less than the maximum allowable tax levy increase of 2.93%.

The budget is organized into three sections: Administrative, Program and Capital.

The Administrative Budget includes all expenses for managing and organizing the affairs of our school system. Examples of administrative expenses include administrator and secretary salaries, attorney and payroll service fees, professional development activities, copying costs and benefits.

Program Budget is the most comprehensive element of our financial plan. Program includes all expenses associated with providing an education to the children and young people of our community. Examples of program expenses include classroom instruction, field trips, special education services for disabled children, textbooks, computer technology, art, music and athletics.

The Capital Budget includes all expenses required to maintain a safe facility. Bond payments are also part of this category. Examples of capital expenses include bus driver training, bus maintenance, building safety inspections, fire prevention, maintenance and custodial salaries & benefits, fuel, power and water.
