2024 - 2025 BUDGET NEWSLETTER

Dear District Residents:

As **Proposition I,** The Board of Education submits the 2024-2025 District Expenditures for community approval. The \$20,989,629 proposed expenditure represents an increase of \$261,793 or 1.263% more than last year's budget.

This is a very modest increase as we continuously look for cost containment measures while still providing a robust educational program for our students. Although health insurance costs continue to rise we are very appreciative of the cooperative relationship we have with our unions as we work together on strategies that help mitigate health insurance premium increases.

We did have debt from a past capital project come off the books this year which aided in the low expenditure increase, however State aid for that project also ends so the expenditure/revenue split is essentially a wash.

The largest budget difficulty the district is facing is the method by which foundation aid is being distributed for the 2024-2025 school year. The Governor had initially proposed the elimination of a portion of save harmless for districts across the State including Madrid-Waddington that would have resulted in a loss for our district of \$8,000 from the current year's allocation. The Governor also proposed an inflation factor of 2.4% which is lower than the prescribed 4.1% that should have been used in the foundation aid calculation. When the State budget was passed, save harmless was restored, however the inflation factor was only calculated at 2.8%. Overall this means that Madrid-Waddington's foundation aid for the 2024-2025 school year will remain at the same level as the current school year. The State budget includes language that will task the Rockefeller Institute with a foundation aid study so the future of State aid is very uncertain at this time.

Our district has remained conservative in our spending over the last few years so we are able to balance the budget with a \$1,305,000 fund balance allocation and a comparably moderate tax levy increase of \$137,517 or 2.87% which is well under the district's allowable tax cap of 9.61%. The board is firmly committed to maintaining a thriving education program while minimizing the financial impact on our residents and striking the right balance between the tax burden and district sustainability.

Proposition II is the election of two members to the nine (9) member Board of Education. We are grateful that both incumbents, Bruce Durant and Robert Smith, have chosen to run for re-election, and we extend our thanks to them as they seek voter support to continue serving their community.

Proposition III requests community approval for the purchase of one (1) 72-passenger handicapped bus and one (1) 24-passenger handicapped bus at a cost not to exceed \$350,000. We continue to see inflation heavily influence the prices of these purchases. Thankfully, our voter approved transportation reserve is solid, and given that the State reimburses 90% of our transportation expenses, this proposition will not impact the tax levy.

Proposition IV seeks community endorsement to sustain the ongoing practice of conducting an annual capital outlay/mini-renovation project. In New York State, districts are permitted to carry out yearly capital outlay projects, costing no more than \$100,000, with voter approval. These projects are reimbursed based on our building aid ratio, currently set at 90%, resulting in an approximate net cost to the district of \$10,000. This year's project will continue our schedule for replacing windows in the elementary wing. The reimbursement from last year's project covers 90% of the funding for the new project, with the remaining funds sourced from our building reserve to avoid impacting the tax levy. This is part of a long-range strategy in which the building aid returned in the following year will continue to fund additional mini-renovation projects as a regular part of the district's budget.

Propositions to be voted on May 21, 2024

PROPOSITION I: BUDGET

Shall the Board of Education of the Madrid-Waddington Central School be authorized to expend the sum of \$20,989,629 for the 2024 -2025 school year and to levy the necessary tax for this purpose.

PROPOSITION II: BOARD OF EDUCATION

- ◆ The election of two (2) members to the nine (9) member Board of Education.
- ◆ Two (2) five-year terms are open.
- Candidates include the following:

Bruce Durant Robert Smith

The ballot will be accepting write-in candidates.

PROPOSITION III: BUS PURCHASE

Resolved that the Board of Education of the Madrid-Waddington Central School District be authorized and directed to purchase one (1) 72-passenger handicapped bus and one (1) 24-passenger handicapped bus to expend therefore an aggregate sum, not to exceed \$350,000; which sum shall be raised by tax on the taxable property of the District; and That the Board of Education be authorized to expend funds from the existing Transportation and Equipment Capital Reserve Fund to fund the cost of the buses and vehicles in whole or

That the Board of Education be authorized in accordance with the provisions of the Education and Local Finance Law to borrow on the credit of the District a sum, not to exceed \$350,000, to fund the cost of the buses and to issue obligations of the District not to exceed that amount to finance the purchase of the buses and vehicles in whole or part.

PROPOSITION IV: CAPITAL OUTLAY

Resolved that the Board of Education of the Madrid-Waddington Central School District be authorized and directed to expend up to \$100,000 from the Building Reserve in part or whole which includes the removal of windows in select classrooms and offices and installation of new thermally broken, aluminum double hung windows with insulated glass. The size and color of the new windows will match the existing windows. Work will also include painting the existing steel lintels above the windows and sealing the perimeter of the window units.

The proposed educational spending plan for the upcoming school year at Madrid-Waddington represents a spending increase of 1.263%, or \$261.793 Our operation will require a tax rate of 2.869%, less than the maximum allowable tax levy increase of 9.61%.

The budget is organized into three sections: Administrative, Program and Capital.

The Administrative Budget includes all expenses for managing and organizing the affairs of our school system. Examples of administrative expenses include administrator and secretary salaries, attorney and payroll service fees, professional development activities, copying costs and benefits.

Program Budget is the most comprehensive element of our financial plan. Program includes all expenses associated with providing an education to the children and young people of our community. Examples of program expenses include classroom instruction, field trips, special education services for disabled children, textbooks, computer technology, art, music and athletics.

The Capital Budget includes all expenses required to maintain a safe facility. Bond payments are also part of this category. Examples of capital expenses include bus driver training, bus maintenance, building safety inspections, fire prevention, maintenance and custodial salaries & benefits, fuel, power and water.
